Deans were asked to submit names of representatives from their colleges to serve on a newly formed Fulbright Committee that will be appointed by Dr. Kent.

4. Other: The Fall 2024 commencement is scheduled for December 13, 2024 at 10:00am. Dr. Kent announced that the university will be graduating its 100,000th student at the ceremony.
